I agree to save and make harmless and indemnify the CLUB from and against all lawsuits, claims, actions, costs, or expenses in respect to any death, injury, loss, or damage to myself or my property howsoever caused, arising out of or in connection with the events and whether the same may have been contributed to or occasioned by the negligence of the CLUB. I recognize and acknowledge that there are inherent risks and hazards involved in participating in the events including, but not restricted to, such hazards as danger from avalanches, sudden changes in weather, falls on steep terrain, failure of equipment, and the possibility of becoming lost, as well as all other hazards associated with hiking, mountaineering, wilderness travel, and any other pursuits of the CLUB, and I further agree to bear any and all costs of rescue or medical attention rendered to me personally and arising from my participation in the events.
